

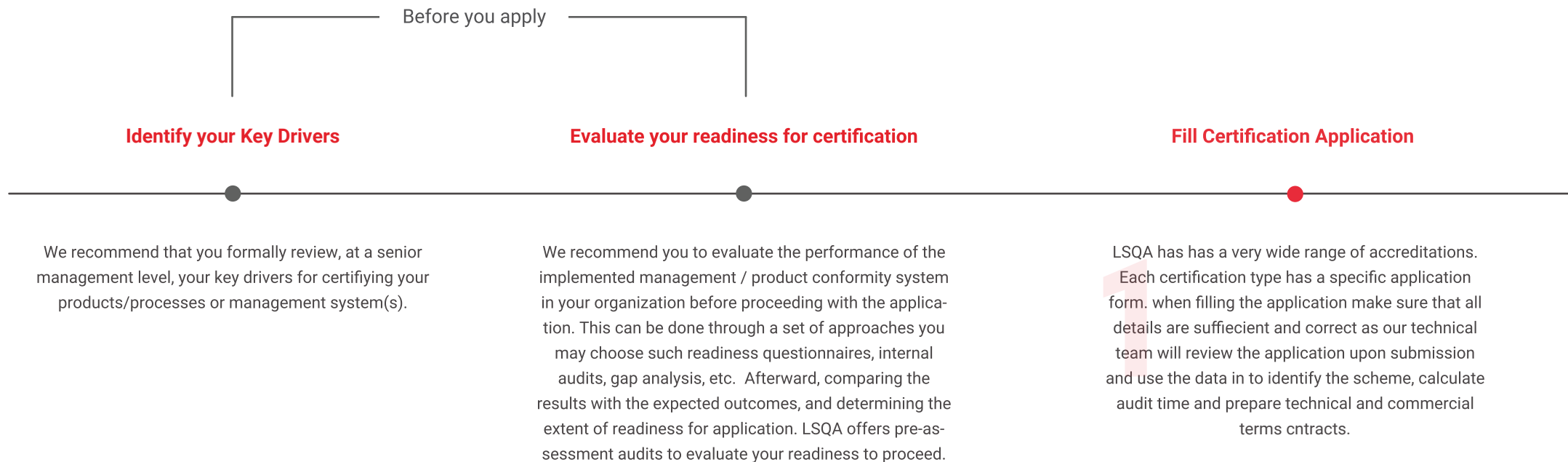

Initial Assessment/ Audit

After signing the services/commercial contract; The Audit team will conduct audits to your management system/ product conformity system at your premises/ site. Our auditors will gather information about the maturity and level of implementation and identify areas of non compliance, if any, to be resolved as well as we will recommend improvements

Reporting the assessment results

Upon full compliance with standard(s) requirements, completing **improvements** or closing **non-compliances**, our auditors will gather all information in a sepecific reports to be submitted for decision. You'll get a copy of detailed technical report.

Certificate Grant

Your organization will get a registration certificate (traceable hard and soft copy).

Surveillance Audits

You will be visited by our auditors on annual basis to chaeck maintain- ing your compliance and verify the effectiveness of your system. At this point, our auditor will provide support and review how your system is being managed
